EXECUTIVE DIRECTOR'S REPORT

Executive Director Rosas presented the school application request for FY22-23 from PAEC. He recommends the Commission not support schools direct but should continue to support the agency programs that have a direct impact in schools. Commissioner Gilhooley says this will encourage schools to use community therapists for treatment and not counselors from school for students

Executive Director Rosas reported that the Proviso Township Mental Health and Proviso Public Partnership employees are going to Proviso Math and Science Academy to instruct 100 students in the basics of CPR and Opioid Overdose training on Tuesday, May 24th. The students will learn basics skills which will make them proficient in performing CPR until help arrives. Students will receive a certificate upon completion of class.

Executive Director Rosas reported that the new Microsoft 365 Business Standard license is now \$12.50 per user per month, a total of \$1,050.00 for a yearly subscription.

Executive Director Rosas reported that Noventech quoted the Commission \$2,475.00 to upgrade the hardware and the software needed to meet medicaid requirements. This is also all part of updating the Commission's cyber/security required by the insurance underwriter which was approved by the Board back in February of this year.
